*To qualify for the parish tuition rate, families must have regular mass attendance. Newly registered members will be eligible after six months of regular mass attendance.

**Tuition increases by \$300 if volunteer time is not met.

Please note, tuition increased \$100 per year per child for the 2016–2017 school year over the 2015-2016 rates.

The tuition payment schedule using FACTS Tuition Management is July 2016 – April 2017. You may deduct a \$100 discount for paying in full by June 10, 2016.

2016-2017 Tuition and Fees for Pre-Kindergarten:

Registration	\$ 50 per child
Activity Fee	\$ 125
Morning or afternoon session	\$ 12 per session
Lunch time care	\$ 1
All day	\$ 25 per day

We ask for a minimum of 3 morning sessions per week.

After Care (3:00 p.m. until 6:00 p.m.):

Registration	\$50 per family
First hour, first child	\$ 6
Per hour for first child, after first hour	\$ 4
Per hour for each additional child	\$ 3

There is a \$1.00 per minute late fee assessed for late pick-up after 6:00 p.m. from After Care.

St. Christopher School understands the demands on and sacrifices made by families to afford a quality, Catholic education. We also have to be good stewards of our parish resources, so tuition must be paid on a timely basis. It is the responsibility of the parents or guardians to arrange for a tuition plan with the Tuition Specialist prior to the beginning of the school year.

Tuition Payments Plans:

- Yearly: If tuition is paid in full by June 10, 2016, you will receive a \$100 discount.
- Semi-Annual: Two payments. One-half of tuition is due August 1. The remaining half is due December 1.
- Monthly: Monthly payers must use FACTS Management Company to pay on a 10-month or 11-month plan, beginning in July. Monthly payers are able to choose between the 5th or the 20th each month to make their payments.

Financial Assistance: Limited financial assistance is available from SCS. To enroll, please contact our Tuition Coordinator, Jessica Sinkovic for more information.

Arrears Tuition: Any tuition not paid in a timely manner may result in a student's withdrawal from school. All financial deficiencies and fees, including lunch, Aftercare, tuition, etc. must be resolved prior to the enrollment for the next school year and/or transferring of student records to another school.
